NOTIFICATION

In exercise of powers conferred by Rule-6 of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and Members of the State Commission and District Commission) Rules, 2020 and on the recommendation of a Selection Committee, the Governor of Himachal Pradesh, is pleased to appoint Justice Inder Singh Mehta (Retd.), Village and Post Office Lippa, Tehsil Moorang, District Kinnaur, Himachal Pradesh as President, H.P. State Consumer Disputes Redressal Commission, Shimla, on the following terms & conditions:-

- 4. He shall submit a certificate of physical fitness as indicated in Rule-6 (12) of the ibid Rules, duly signed by a Civil Surgeon or District Medical Officer.
- 5. He shall furnish an undertaking that he does not or will not have any such financial or other interest as is likely to affect prejudicially his functions as a President, H.P. State Consumer Disputes Redressal Commission, Shimla.
- 6. He shall, before entering upon his office, make an oath of office in Form No. I and oath of secrecy in Form No. II, Annexed to Himachal Pradesh Consumer Protection Rules, 2021.
