Notification

The Governor, Himachal Pradesh, in exercise of the powers conferred under Sub Clause (a) of Sub Section (1) of Section 10 of the Consumer Protection Act, 1986 (As amended by Act No. 62 of 2002) and on the recommendations of the Selection Committee, is pleased to appoint Shri Rattan Singh, presently posted as District and Session Judge, Hamirpur, Himachal Pradesh, as President, District Consumer Disputes Redressal Forum, Una, Hamirpur & Bilaspur with Headquarter at Una for a term of five years or upto the age of sixty five years, whichever is earlier, with effect from the date of his assumption of the charge on the terms & conditions stated below:-

1. Sh. Rattan Singh (District & Session Judge) shall be entitled to salary, payable to him as District Judge but the pay plus pension shall not exceed to the last pay drawn by him before retirement as District & Session Judge. He shall also be entitled to the increase in Dearness allowance on account of revision from time to time, subject to the condition that no I.R. and relief on pension shall be payable during the currency of tenure of his appointment as President of District Forum.
2. On Official tour as President of the District Forum, Sh. Rattan Singh, shall be entitled to travelling and daily allowances at the same rate as admissible to the highest Grade-I Officer of the State Government under the State Government rules in vogue as amended from time to time.
3. The other terms & conditions of the appointment would be governed by the provisions of the H.P. State Consumer Protection Rules, 1988 as amended from time to time.
