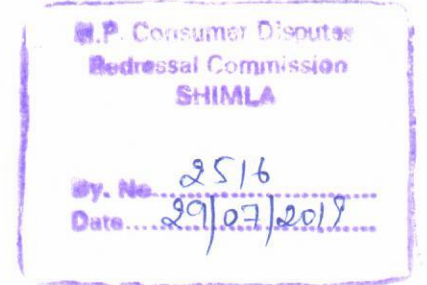

Subject : Preponement of dates of Circuit Bench Sitzings of the National Commission at Shimla, Himachal Pradesh from 09th September, 2019 to 13th September, 2019.

Respected Sir,

In continuation of this Commission's earlier letter of even number dated 28th May, 2019, (copy enclosed), I am directed to say that the Hon'ble President, National Commission has preponed the dates of the Circuit Bench sittings of the Commission at Shimla from **09th September to 13th September, 2019**. Previously the period of the Circuit Bench sittings of the Commission was **23rd September to 27th September, 2019**.

May I, therefore, request kindly to issue necessary instructions to the concerned officials of the State Government for making the arrangements as requested in our previous letter for holding the Circuit Bench sittings of the National Commission at Shimla from **09th September to 13th September, 2019** at the earliest and also nominate a Nodal Officer of the State Government to coordinate with the officials of the National Commission in this regard.

Since the National Commission has to issue Notices to the parties for appearing before the Circuit Bench at Shimla 30 days in advance, it is requested to confirm the venue of the sitting at the earliest to enable us to take further steps for issuance of notices and for making necessary arrangements for holding the Circuit Bench sittings of the National Commission at Shimla.

Further, the State Government is also requested to give wide publicity for the information of general public with regard to holding of the Circuit Bench sittings of the National Commission from **09th September to 13th September, 2019** along with its venue at Shimla so as to enable the consumer to file fresh cases before the Circuit Bench.
