### Notification

The Governor, Himachal Pradesh, in exercise of the powers conferred under Section 16(1) (a), 16(2) and 16(3) of the Consumer Protection Act, 1986 (as amended by Act No. 62 of 2002) and in consultation with the Hon'ble Chief Justice of the High Court of H.P. is pleased to appoint Mr. Justice P.S. Rana, Judge of High Court of H.P. as President of H.P. State Consumer Disputes Redressal Commission (to be known as State Commission) with effect from the dated he assumes the charge as such on the terms and conditions stated below:-

1. Mr. Justice P.S. Rana, on appointment as President of State Commission, shall be entitled to salary, allowances and other perquisites as were available to him as Judge of High Court (last pay drawn minus pension). He shall also be entitled to the increase in Dearness allowance on account of revision from time to time subject to the condition that no I.R. and relief on pension shall be payable during the currency of tenure of his appointment as President of State Commission after his retirement as sitting Judge of High Court.
2. Mr. Justice P.S. Rana shall hold office of the President, State Commission for a term of 5 years or upto the age of 67 years, whichever is earlier and shall not be eligible for re-appointment.


