- 4. He shall submit a certificate of physical fitness as indicated in Rule-6(12) of the ibid Rules, duly signed by a Civil Surgeon or District Medical Officer.
- 5. He shall furnish an undertaking that he does not or will not have any such financial or other interest as is likely to affect prejudicially his functions as President, District Consumer Disputes Redressal Commission.
- 6. He shall, before entering upon his office, make an oath of office in Form No.1 and oath of secrecy in Form No.II, Annexed to Himachal Pradesh Consumer Protection Rules, 2021.
- 7. The appointment of the aforesaid candidate is subject to the conditions that his antecedents will be verified within one month from the date of appointment and in case anything adverse is found, he shall be removed immediately from service at once without any further notice to him in this regard.
- **8.** He can be transferred to any District Consumer Commissions in the State of Himachal Pradesh.
