

#### Eligibility criteria for the post of Member Part-time, State Commission:

- 3(2) "A person shall not be qualified for appointment as Member State Commission unless he/she-
  - (a) is of not less than forty years of age;
  - (b) has an experience of at least ten years as Presiding Officer of a District Court or of any Tribunal at equivalent level or combined service as such in the District Court and Tribunal:

Or

- (c) possesses a bachelor's degree from a recognized University; and
- (d) is a person of ability, integrity and standing, and having special knowledge and professional experience of not less than ten years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine.

## Eligibility criteria for the post of Member Part-time, District Commission:

- 4(2) "A person shall not be qualified for appointment as Member District Commission unless he/she-
  - (a) is of not less thirty-five years of age;
  - (b) possesses a bachelor's degree from a recognized University; and
  - is a person of ability, integrity and standing, and having special knowledge and professional experience of not less than ten years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine.

#### **Tenure**

The appointment of Members of State/District Commissions shall be for a period of four years or upto the age of sixty five years, whichever is earlier as per Rule 10 of Consumer Protection (qualification for Appointment, Method of Recruitment, Procedure of Appointment, Term of Office, Resignation and Removal of the President and Members of the State Commission and District commission) Rules, 2020.

#### Remuneration/honorarium payable to Members of District Commission:

As per Rule 5 of Himachal Pradesh Consumer Protection (Salary and other terms and conditions of service of the President and Members of the District Commission/State Commission) Rules, 2021, the member of State Commission shall be paid a consolidated remuneration /honorarium at the rate of Rs. 2,500/- per sitting, while the members of District Commissions shall be paid honorarium at the rate of Rs. 2,000/- per sitting.

Members of State/District Commission shall be entitled to travelling and daily allowances on official tours equivalent to entitlements of Grade-I Officers of the State Government. They shall not be entitled to official vehicles as well as Government Accommodation.

#### Selection Procedure:-

The Selection of the Members of the State/District Commissions shall be made by the Selection Committee as per Rule 6(9) of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Amendment Rules, 2023 on the basis of the performance in a written test consisting of two papers as specified below, with the qualifying marks of fifty percent in each paper and there shall be *viva voce* of 50 marks.
