H.P. STATE CONSUMER DISPUTES REDRESSAL COMMISSION, SHIMLA-09.

OFFICE ORDER

In exercise of the powers conferred by Rule 7 of "The Salaries and Allowances payable to and other terms and conditions of Services of the officers and other employees of the State/District Consumer Disputes Redressal Commissions Rules, 2024" framed under Consumer Protection Act, 2019 (35 of 2019) and on the recommendations of Departmental Screening Committee constituted pursuant to letter No. PER (AP)-C-B-(2)-2/2015 dated 02.12.2023 issued by the Government of Himachal Pradesh, Department of Personnel (AP-III), the Hon'ble President, H.P. State Consumer Disputes Redressal Commission is pleased to order regularization of the daily waged services of Sh. Rajesh Kumar, Safai Karamchari-cum-Chowkidar, after his completion of 4 years of continuous service in the District Commission, Hamirpur in the pay scale of Level 1, Cell 1, (i.e. Rs.18000-56900) applicable to the post in Himachal Pradesh Civil Services (Revised Pay) Rules, 2022. After regularization, Sh. Rajesh Kumar shall continue to perform the same duties as he was performing on daily wage basis.

The above regularization shall be subject to the following terms and conditions:-

- 1. The appointment/regularization is purely temporary and liable to be terminated at any time by serving a month notice.
- 2. The regularization shall be subject to verification of character and antecedents, as provided in the H.P. Financial Rules.
- 3. The appointment shall be subject to the production of Medical Certificate of fitness from the District Medical Officer of the Government Hospital.
- 4. He shall be liable to serve on the establishment of H.P. State Consumer Disputes Redressal Commission as well as in any District Commissions in the State of H.P.
- 5. He shall be required to produce character certificate from the Magistrate First Class or any Gazetted Officer to whom the candidate is known for the last three years.
- 6. He shall be required to produce all original certificates in support of his educational qualification, age, Himachali bona fide and belonging to any reserved Class, if any, against which he is proposed to be appointed at the time of joining the post. If the documents submitted by him are found to be false, his services will be terminated without any further notice.
- 7. He shall have to submit assets and Liability statement.
- 8. He shall be on probation for a period of two years from the date of joining.
- 9. The regularization will be with prospective effect, i.e. from the date of issue of regularization order/Joining.
- 10. He shall produce certificate that he has not more than one living wife.
- 11. No. T.A/D.A will be admissible for joining the duty.

12. He shall require to take oath/affirm on the following form:-

I,_____do hereby swear and solemnly affirm that I will be faithful and bear true allegiance to the constitution of India as by-laws established and that I shall carry out the duties of my office with loyalty, honestly and impartiality.

In case the above mentioned terms and conditions are acceptable to him, he should submit his joining report to the office of Ld. President, District Consumer Commission, Kangra at Dharamshala within a period of 15 days, failing which, the offer shall stand cancelled automatically.
