

H.P. STATE CONSUMER DISPUTES REDRESSAL COMMISSION, SHIMLA-9

OFFICE ORDER

Whereas tentative gradation list of the officers and other employees of State/District Consumer Disputes Redressal Commissions on the establishment of H.P. State Consumer Dispute Redressal Commission as it stood on 31.03.2024 was issued vide letter dated HP/CPC/1-147/97-IV-1045-1049 dated 13.05.2024 and objections, if any, to the tentative gradation list were called for by 28.05.2024.

In response to the above circulations, four officials, namely, Ms. Usha Devi, Civil Nazir, DCC, Kangra at Dharamshala, Sh. Raman Parihar, Civil Nazir, DCC, Una, Sh. Rajan Bhagra, Civil Nazir, H.P. State Consumer Commission and Ms. Bharati Verma, Record Keeper, DCC, Mandi have filed their objections. The final seniority list is circulated as it stood on 31.03.2024. Further, no

representation against the final seniority will be entertained except clerical mistake which will only be entertained within a period of 3 days from the date of issue of final seniority list.


