| | (c) | In Schedule –II , existing Serial No.14 against column “Mode of appointment/ length of service” the existing provisions shall stand substituted as under:- “By promotion from amongst Process Servers having three years regular service or regular combined with continuous ad hoc service failing which by direct recruitment initially on contract basis as per procedure prescribed in Schedule-IV (Part-D)”. |
| | (d) | In Schedule –II , existing Serial No.15 (B) against column “Mode of appointment/ length of service” the word “ Chowkidar ” after word Peon shall stand deleted. |
| | (e) | In Schedule –II , existing Serial No.16 against column “name of post” the word “ Chowkidar ” after word Peon shall stand deleted. |
| | (f) | In Schedule –IV, Part-B (B) after words “other class –IV officials”, the words “ except Chowkidar ” shall stand incorporated. |
| | (g) | In Schedule –IV, Part-D existing head/title, shall stand substituted as under:- “WRITTEN TEST FOR THE POST OF BAILIFF AND PROCESS SERVERS (REGULAR/ CONTRACT BASIS)”. |
| | (h) | In Schedule –IV, Part-E after word Peon, the word “ Chowkidar ” shall stand deleted. |
